About This Brochure

This brochure contains important pipeline facility identification, damage prevention, and safety information. It has been sent to you because you live or work in the community that is located within an area where Island Energy Services (formerly Chevron) owns and operates underground pipelines or pipeline facilities (terminals).

Island Energy is committed in helping communities that we serve to live safely near pipeline facilities we operate. Statistics indicate that damage from excavation related activities is a leading cause of pipeline accidents. If you are a homeowner, excavator, farmer, or developer, we need your help in preventing pipeline emergencies. Never guess where a pipeline is located, always Call 811 Before You Dig.



HOW DO YOU KNOW WHERE PIPELINES ARE?

- Some of our pipelines are above the ground and can easily be seen, but most pipelines are buried below the ground surface within areas called Right-Of-Ways.
- Pipeline operators often place markers along their pipeline (see pictures below). Pipeline markers are generally yellow, red, and/or black with information regarding the product contained in the pipeline and the contact information for the operator.
- The National Pipeline Mapping System (NPMS) can provide you with a list of pipeline operators and pipeline maps in your area. Visit www.npms.phmsa.dot.gov
- It is against the law for any person to willing and knowingly deface, damage, remove or destroy any pipeline sign or right of way markers. If you know of any damaged or missing pipeline markers or have seen someone damage or remove one, please report it to 1-808-682-4711.

Excavation Safety

At Island Energy, we are committed to conducting our operations in a safe, environmentally sound manner. In order to protect the public and environment, we perform comprehensive risk assessments and develop prevention and mitigation plans that reduce those risks. In addition, the Federal government agencies frequently audit and inspect our facilities and audit our programs, procedures, and safety aspects of our operations. While every necessary measure is taken to ensure safe pipeline operations, accidents can still occur.

A damaged pipeline facility may release flammable products into the soil, water, or the air that can be harmful to people and the environment. Please read this material carefully so you are aware of the hazards associated with these failures. such as potential for fire and/or explosion, inhalation toxic fumes, and irritation to skin, eves, nose, or throat if in close or prolonged contact with harmful substances.

Be a Leak Detective! use sight, sound, and smell test:

HOW YOU CAN RECOGNIZE A LEAK?

- Sight: Dead or off-colored vegetation, pools of liquid or clouds of vapor around a pipeline right-of-way could indicate a leak.
- Sound: A hissing or roaring noise near a pipeline.
- Smell: An unusual odor or strong petroleum odor in the pipeline area can also indicate a leak.

WHAT SHOULD YOU DO IF THERE IS A LEAK?

- Leave the area immediately on foot. Try to direct any other bystanders or unsuspecting individuals to leave the area. Attempt to stay upwind.
- Turn off all equipment and eliminate any ignition source, do not do anything that may make a spark.
- Call 911 or other emergency responders such as your local fire department from a safe location. Provide them with your name, phone number, a description of the leak and its location, so that the proper response can be initiated.
- If possible, notify the pipeline owner or operator from a safe location you can find • the emergency number located on pipeline or facility sign.
- **DO NOT** come into contact with liquids or vapors (i.e. do not touch or breathe).
- DO NOT drive into a leak area and do not attempt to restart your vehicle
- **DO NOT** light a match or smoke.
- **DO NOT** attempt to operate pipeline valves.
- DO NOT attempt to extinguish a petroleum product fire





Island Energy operates a petroleum import terminal in Kapolei, Hawai'i, located on the island of O'ahu. With two 23-mile pipelines, Island Energy transports motor gasoline, jet fuel, diesel, and naphtha from Kapolei to its Marine Terminal at Pier 30, and jet fuel to the airport. Island Energy also owns and utilizes pipelines supporting the terminals at Port Allen (Kaua'i), Kahului (Maui), and Hilo (Hawai'i Island), To learn more, visit us at www.islandenergyservices.com

HOW DO PIPELINES AND TERMINALS HELP YOU?

- Pipelines offer safe, efficient, and reliable transportation to bring refined petroleum products to YOU, the consumer.
- Transportation of petroleum products by pipeline helps keep consumer costs low. Pipelines are more cost-effective than the alternative transportation options and require significantly less energy to operate than operating trucks and have a much lower carbon footprint.
- The terminal facilities are an important link in the petroleum distribution chain and offer safe and reliable storage of fuels for automobiles, trucks, aircraft, and off-road equipment

WHAT DO WE DO TO KEEP YOU SAFE?

- We belong to One Call notification centers which notify those doing work in the area where our pipeline is located.
- We regularly patrol our pipelines and conduct walk-arounds of our terminals to inspect them for any signs of damage or leaks.
- We use computerized monitoring systems to constantly monitor our pipeline facilities from a remote control room and use highly sophisticated technology to detect leaks.
- We operate and maintain our pipeline facilities in accordance with all applicable laws, regulations and best industry standards, and train our operators to recognize any irregularities or deviations from normal operations.
- In accordance with the Code of Federal Regulations (49 CFR 195), we have developed and maintain an Integrity Management Program that outlines how we assess, inspect, and repair our pipelines and terminals in order to ensure safe operations and prevent any impact on the public or the environment.
- As part of our Emergency Response Planning procedures, we keep local and state emergency responders and public officials in your area informed about the location of our pipeline facilities and what to do in case of an emergency.

SAFE EXCAVATION TIPS AND FACTS

- Hawai'i One Call law requires all excavators planning to conduct an excavation on public or private property to notify the Hawai'i One Call Center (HOCC) at least 5 working days prior to excavation.
- You can use the National 811 One Call number or contact HOCC directly by phone 1-866-423-7287 (operated 24/7) or online at www.callbeforeyoudig.org.
- Because even relatively minor excavation activities like landscaping or fencing can cause damage to a pipeline or its protective coating, always Call 811 or contact the One Call Center directly before engaging in any construction, excavation, farming or digging activities.
- The One Call Center will notify the appropriate pipeline operating companies and you will be advised if any buried utilities exist near your job site.
- Our representative will mark the location of the buried pipelines and be present on site if the pipeline is to be exposed. Our representative must be present during and after the excavation activities to verify pipeline integrity, adequate support of the line while it is exposed and that there is proper backfill, as well as perform a visual inspection of any exposed pipelines.

NOTE: If you cause or witness even minor damage to a pipeline or its protective coating during the course of an excavation or digging project, please notify the pipeline company immediately. DO NOT bury the pipeline that has been damaged or dented by your excavation equipment! If you witness damage to pipeline, or to report any suspicious activity on a pipeline right-of-way, call 808-682-4711.



PLANING A HOME IMPROVEMENT PROJECT? KEEP THIS IN MIND:

- Something as simple as repairing or installing a fence, planting a tree, or building a • shed that involves excavation can damage a pipeline.
- Pipeline right-of-ways must be kept free from structures and obstructions to provide clear access to a pipeline for maintenance and in the event of an emergency.
- If a pipeline crosses your property, do not plant trees, dig, build, or store anything on the right-of-way.
- Pipeline markers in and around your neighborhood may not show the exact location of the underground pipeline, so do not make any assumptions on its location or depth.
- Use the One Call system so that pipelines can be first marked and the right-of-ways staked before starting your project.
- The One Call system is not an emergency hotline. If you suspect a leak or in the event of emergency, call 911. Follow the safety procedures in this brochure
